Guidelines for VRET Exempted Admissions

It is hereby notified for information to all VRET exempted category applicants that the admission process/interview shall be conducted in the following manner now —

a. Important Dates-

Declaration of list of Eligible candidates

01.05.2024, 05.00 PM

Interviews/Presentation

09.05.2024 or 15.05.2024

(as notified by the department concerned)

- b. Departments will download application forms and supporting documents of VRET-Exempted candidates online on or after 30.04.2024. After checking their eligibility (through Admission Committee) HoD concerned will send interview letters through email and through speed/registered post to the eligible candidates and will arrange interview/presentation in blended mode for all VRET Exempted category candidates between 09.05.2024 to 15.05.2024. However, candidates interested to appear in interview online must have got prior approval from the HoD concerned for the same.
- c. Departments will prepare the list of candidates called for interview and will publish it on website with date of interview on or before 01.05.2024.
- d. In their call letters the HoD concerned will mention that the candidate has to come with following documents to attend the interview with a presentation/research proposal -
 - 1. 10th (HSC) Mark sheet (Mandatory)
 - 2. 12th (HSSC) Mark sheet (Mandatory)
 - 3. UG Mark sheet (Mandatory)
 - 4. PG Mark sheet (Mandatory)
 - 5. Transfer Certificate/ College Leaving Certificate (Optional), if available
 - 6. Caste/Category/PWD Certificate, if any (Mandatory if applied under any category)
 - 7. Income certificate for OBC, if any
 - 8. If applied for VRET Exempted, then one document in support of exemption claimed and NoC (mandatory)
 - 9. Copy of application form submitted online (Mandatory)
- Admission Committee of the department may verify the documents of the candidates appearing for interview.
- .f. Candidates will attend the interview on scheduled dates and will give their presentation before the DRC concerned. No TA/DA will be paid to the candidate by the University for attending interview.
- g. A candidate appearing in a subject other than his PG subject has to submit the proposal/presentation with justification for such change to DRC. All such candidates must

submit the proposal to the HoD concerned well in advance for its evaluation by the members of DRC concerned.

- h. Departments will prepare merit list of the selected candidates according to the provisions of Ph. D. Regulations 2023 and VRET- Exempted 2023-24 Admission Procedure and will declare the result/list of selected candidates on or before 16.05.2024 on university website. Departments will also send emails to the selected candidates for information about their selection.
- i. Selected candidates may submit their prescribed admission fee online (www.new.ggu.ac.in) on or before 24.05.2024 and may submit a copy of receipt to the HoD concerned to confirm his/her seat for admission. However, all candidates shortlisted for admission have to report the department with all original documents on or before 31.05.2024 and have to submit their Transfer Certificate (TC) in original to the department. In case, the selected candidate will not submit the fee receipt on time or will not submit the TC after submitting fee, then the department concerned may cancel the admission of such candidate and may allow the admission of other candidates from waiting list.
- j. Pre-Ph. D. Course Work of admitted students shall be started from 01.07.2024.
- k. All the guidelines for Admission and Ph. D. Regulations are available on university website www.new.ggu.ac.in. Admission Committee and DRC of the departments have to follow the guidelines and provisions of Ph. D. Regulations 2023 for all above said process.
- Candidate admitted to Pre-Ph. D. Course Work may claim their fellowship from the date of commencement of classes of Pre-Ph. D. Course Work, if eligible.
- m. All applicants are advised to visit university website www.new.ggu.ac.in regularly for getting updates from time to time.
